









Supplementary Figure 3 Prevalence rates A and DALYs rates B of anorexia nervosa in different age groups globally. DALYs disability-adjusted life years.




Supplementary Figure 4 Prevalence rates A and DALYs rates B of bulimia nervosa in different age groups globally. DALYs disability-adjusted life years.








