However, for the sake of usefulness some examples, or even a tentative list of relations between viral architecture and either viral antigenicity, infectivity or pathogenicity could be added to the text. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (3) The “Author Contributions” section is missing. Please provide the author contributions. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
