The idea of medical student involvement in the pandemic is an interesting and somewhat controversial one. Unfortunately, this survey and its interpretation does not accomplish this. The take away points from the survey involve demographics of those that state they are willing to participate which is not discussed in a way that advertises this as useful information. Additionally, survey shows knowledge regarding the pandemic and an interpretation that those without good knowledge would not be equipped to help in the pandemic.
