The authors concluded that preoperative ERCP findings might aid the diagnosis of Mirizzi syndrome with cholecystocholedochal fistulas. The authors should show the diagnostic approach of MS patients, including other modalities such as MRCP, CT, etc. Besides, the author should provide more information about the final endoscopic outcome; The sample size of patients with MS and cholecystocholedochal fistulas is small. It may be difficult to determine the factors predicting cholecystocholedochal fistulas in only 21 patients with MS and cholecystocholedochal fistulas. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 33 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A, Grade B and Grade C. Although the language editing certificate issued by Editage was provided, the language needs to be further improved. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form, the Copyright License Agreement, and the Institutional Review Board Approval Form. The Informed Consent Form was waived. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was performed without financial support. The topic has not previously been published in the WJG. The
