readability. The subject that was chosen by the authors is an important topic within our field, but this manuscript is difficult to read due to the lack of tables and figures. This article could be acceptable for publication after major revision. (3) Format: 1 figure. 132 references were cited, including 55 references published in the last 3 years. One self-citing article. 2 Language evaluation: A and B. Language editing certificate was provided by a native English speaker. 3 Academic norms and rules: The authors signed the conflict-of-interest disclosure form and copyright license agreement. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has published two articles in the WJG.

Editorial Office Director: Recommend for potential acceptance. 1. Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor. The topic of the paper is the post-transplant diabetes mellitus and preexisting liver disease, and is within the scope of the WJG. The reviewers stated that this mini-review is a well-detailed analysis of the intertwining relationship between diabetes and advanced liver disease in pre- and post-transplant patients, which is good and important. However, the reviewer 00058696 pointed out that this manuscript is difficult to read due to the lack of tables and figures, the authors need to add them. The questions raised by the reviewers should be answered. 2. Language quality: 1A1B. One of
