No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by clinical research grant from Pusan National University Hospital in 2020. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG.
