The questions raised by the reviewers should be answered; and (3) Format: There are no tables and figures. A total of 67 references are cited, including 19 references published in the last 3 years. There is 1 self-citation (Ref. 1). The topic of the self-citations is related to this study. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by an English expert was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; and (2) Authors should always cite references that are relevant to their study.
