The topic of this manuscript is an observational study of Golimumab in ulcerative colitis, and it is within the scope of WJG. The reviewer 04091933 thought it assesses for the first time the long-term change in the work productivity, daily activities and health related quality of life in patients with ulcerative colitis treated with Golimumab in real clinical practice. The study used the correct methods of modern statistical analysis. One question for why the authors do not report the 24-month results. There are 3 figures and 3 tables. 31 references were cited in
