Grade A; (2) Summary of the Peer-Review Report: The authors report an interesting and large experience of endoscopic removal of rectal carcinoid with excellent results acquired. The authors are suggested to comment on the natural history of the small rectal carcinoid. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 2 figures. A total of 35 references are cited, including 20 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form, the Biostatistics Review Certificate, and the written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Natural Science Foundation of Anhui Province, Key Project of Science and Technology Development Fund of Bengbu Medical College, and Graduate Innovation Program of Bengbu Medical College. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I
