improve the techniques of EUS guided tissue acquisition. Results are very promising. However, there are some issues should be addressed. As authors wrote, larger multi center prospective randomized trials will be needed to confirm the results. When the authors mention univariate and multivariate analyses, they might want to consider call them "univariable" and "multivariable". The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables. A total of 50 references are cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The manuscript is from the United Kingdom. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to complete the Conflict-of-Interest Disclosure Form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the title was more than 12 words. The title should be no more than 12 words; (2) I found no "Author contribution" section. Please provide the author contributions; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed

	<p>numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p>Editorial Office Director: I have checked the comments written by the science editor.</p> <p>Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Gastrointestinal Endoscopy.</p>
