criteria for atrophic gastritis/cancer risk assessment is encouraged. The study has a number of weaknesses as mentioned by authors themselves and these would reduce the strength of the study conclusion. The presence of neutrophil might be associated with atrophic gastritis, but this could be present also without atrophic gastritis. Discussion should be more focused on authors finding. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 39 references are cited, including 18 references published in the last 3 years. There are 12 self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Ministry of Education, Culture, Sports, Science and Technology of Japan; and the Tailor-Made Medical Treatment with the BBJ Project from Japan Agency for Medical Research and Development, AMED. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
