(2) Summary of the peer-review report: This article is well written. The most current literatures were adequately cited. Discussion is almost well organized. An overall theoretical analysis concerning the studied topic is covered to great extent in plausible way. Results is well organized and descriptive. (3) Format: Three tables and six figures; one supplementary table. Forty-one references were cited, including twenty-three references published in the last three years. One self-citing article. 2 Language evaluation: A. Language editing certificate was provided by a native English speaker. 3 Academic norms and rules: The authors provided biostatistics review certificate and the ARRIVE Guidelines. The authors signed the conflict-of-interest disclosure form and copyright license agreement. The institutional review board approval form was uploaded. The authors declared that no animal mode was used in this study. No academic misconduct was found in the Bing search. The CrossCheck investigation: The similarity index between this manuscript and the published ones is too high, which doesn't meet the publishing requirements. The highest single-source similarity index is 6%. 4 Supplementary comments: (1) Invited manuscript. (2) Supported by Instituto de Salud Carlos III and European Regional Development Fund (ERDF). (3) Corresponding author has published two articles in WJG.

The topic of the paper is conservation and variability of Hepatitis B Core gene, and is within the scope of the WJG. Reviewer pointed out that the chosen topic is of great interest for a lot of researchers, results are well organized and descriptive, and figures & tables were informative & well presented. The questions raised by the reviewer should be answered. 2. Language quality: 1A. The authors stated that he is a native speaker, but the reviewer pointed out that minor editing revision is required. 3. Academic norms and rules: I have checked the documents, the conflict-of-interest disclosure form, copyright license agreement, institutional review board approval form or document, and The ARRIVE Guidelines, all of which are qualified. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Invited manuscript. (2) Supported by two grants. (3) Corresponding author has published 2 articles in BPG journals.
