(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors reviewed the current development of dental stem cells for transplantation therapy of stem cells, which was interesting, well organized and adequately conducted. However, Reviewer 03372021 pointed out that the manuscript had some grammatical and spelling mistakes. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJH. 5 Issues raised: (1) The language classification is Grade C.
