They give concise examples for each technology; and (3) Format: There is 1 table. A total of 50 references are cited, including 26 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. No language editing certificate was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJL. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) PMID numbers are missing in the reference list. Please provide the PubMed numbers to the reference list and list all authors of the references. Please revise throughout; and (3) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6 Recommendation: Conditional acceptance.
