However, the authors should summarize more clinical studies of nutrient-gut interactions by using innovative techniques and models for therapies of metabolic diseases. There are a couple of strange sentences and wordings. The manuscript needs to be polished up. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 116 references are cited, including 17 references published in the last 3 years. There are 11 self-citations. 2 Language evaluation: Classification: Grade B, Grade B, Grade B and Grade B. The manuscript is from the Australia. 3 Academic norms and rules: The authors provided tthe signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript.
