No financial support was obtained for the study. The topic has not previously been published in the WJP. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditional acceptance.
