And they found that the use of fluorescence endoscopy was a promising method adding precisely diagnostic value in the early development of neoplasms and tumors, adenomas, assessment of tumor invasion within the gastrointestinal tract and adding therapeutic value within the field of gastrointestinal diseases. The review is useful and helpful. Furthermore, no obvious errors were found in this paper; and (3) Format: There are 3 tables and 2 figures. A total of 45 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the PRISMA Checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJGE. The corresponding author has not published articles in the BPG.
