A total of 35 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. The authors are the native English speakers. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJH. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; and (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
