The topic is within the scope of the WJG. (1) Classification: Grade C, Grade C and Grade D; (2) Summary of the Peer-Review Report: This manuscript has reviewed the latest</p>	[Y]



studies about the optimal way of surgery for advanced colorectal carcinoma with synchronous liver metastases, including conventional and mini-invasive approaches, staged and synchronous resections. It seems meaningful in the colorectal cancer and liver metastases clinically. However, there are some issues should be addressed. The questions raised by the reviewers should be answered; and (3) Format: There are no tables or figures. The authors need to add some tables or figures. A total of 228 references are cited, including 45 references published in the last 3 years. There are 3 self-citations. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. The highest single-source similarity index in the CrossCheck report showed to be 13%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: The authors need to add some tables or figures. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
