12	The 'Core tip' provides a summary (less than 100 words) of the study that outlines the most innovative and important arguments and core contents of the paper and will serve to effectively attract readers.	[ ]

Only the most relevant and current (within the past 5 years) literature is cited, with the exception of rare instances of seminal literature citations. For citations where no author is indicated, a superscript number should be placed at the end of the sentence. No superscript numbers are used when the reference number is described in the text; for example, "The experimental method used has been described in reference [8]."
