No self-citation. 2 Language evaluation: A and 3B. Language editing certificate was provided by CACTUS. 3 Academic norms and rules: The author provided the Biostatistics Review Certificate, Institutional Review Board Approval Form or Document and Signed Informed Consent Form(s) or Document(s). The authors signed the conflict-of-interest disclosure form and copyright license agreement. No academic misconduct was found in the CrossCheck investigation and the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) The topic has not been published in the WJG.(Han Zhang)

Editorial Office Director: Recommend for potential acceptance to the WJG. 1. Scientific quality: I have checked the comments written by the science editor, and I basically agree with the science editor. The topic of the paper is the robotic radical resection of hepatic echinococcosis, and is within the scope of the WJG. All reviewers stated that this is an excellent study about the robotic radical resection of hepatic echinococcosis. The questions raised by the reviewers should be answered. 2. Language quality: 1A3B. The language certificate is provided by editage, but all reviewers pointed out that the manuscript needs to be a minor language editing. 3.
