The study is well conducted and presented. The author should build a model for integrated evaluation such as nomogram. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 6 figures; (4) References: A total of 39 references are cited, including 16 references published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
