The authors have been investigated the difference in mechanisms of the immunosuppressive effects of umbilical cord-derived mesenchymal stem cells and bone marrow-derived mesenchymal stem cells, which is a well-planned and -conducted study. However, some questions raised by the reviewer should be answered; and (3) Format: There are 6 figures. A total of 41 references are cited, including 1 reference published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A. The language editing certificate was provided by the Textcheck. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, The ARRIVE Guidelines, Institutional Animal Care and Use Committee Approval Form or Document, and the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. However, the CrossCheck detection showed a high similarity to published articles (total 5%). The authors need to rephrase the repeated sentences. 4 Supplementary comments: This is an invited manuscript. The study was supported by 3 grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all
