However, minor grammatical errors and typos need to be corrected; and (3) Format: There is 1 figure. A total of 59 references are cited, including 45 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. The language was edited by a professor. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 7% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
