So the questions raised by the reviewers should be answered; and (3) Format: There is 1 figure. A total of 127 references are cited, including 30 references published in the last 3 years. There are 6 self-citations. 2 Language evaluation: Classification: Grade A and Grade B. The authors mentioned that it was an invited manuscript and they had experience of publishing scientific articles for more than one decade, so to request the editor to consider without any English Editing Certificate. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form, but the Copyright License Agreement lacks of the signature in handwritten. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by 2 grants. The topic has not previously been published in the WJSC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or
