Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision; (4) Please provide the informed consent of treatment. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
