**Scope of Work**

1. **Brief Project Description:** Service Provider shall be providing Services related to real world evidence on the impact of new therapies in the treatment of chronic hepatitis C virus (CHC) infection (HEPC-OUT-021). The Services are as set forth in Service Provider's proposal attached hereto and made a part hereof as "Appendix 1".

2. **Acceptance Criteria:**

Acceptance Criteria for Document Deliverables:

For any milestone in which Service Provider submits a document that is a deliverable ("Document Deliverable"), Company shall have the right to review such Document Deliverable and shall notify Service Provider if there are any deficiencies. Service Provider shall use its best efforts to promptly cure any such deficiencies, and after completing any such cure, Service Provider shall resubmit the Document Deliverable for review as set forth above.

Acceptance Criteria for a Deliverable other than a Document Deliverable:

For any milestone in which Service Provider submits a deliverable other than a Document Deliverable, Company shall have the right to review and/or test such deliverable for the functional requirements or acceptance criteria specified for such deliverable and shall notify Service Provider if there are any deficiencies. Service Provider shall use its best efforts to promptly cure any such deficiencies, and after completing any such cure, Service Provider shall resubmit the deliverable for review and/or testing as set forth above. Any applicable warranty period shall only commence after acceptance by the Company.

3. **Compensation.**

A. **Rates and Fees** – For performance of the Services, Company shall pay to Service Provider as specified in Appendix 1, attached hereto and incorporated herein.

- B. Expenses – Company shall reimburse Service Provider for only itemized, documented out-of-pocket expenses that are preapproved in writing by an authorized representative Company and are invoiced in accordance with Company's instructions and the Agreement.
- C. Compensation Limit – Total compensation for Services, including Expenses, shall not exceed shall not exceed \$408,814.00.
- D. Invoice Schedule – Upon execution of the Agreement and Service Provider receipt of a purchase order number, Service Provider shall submit invoices according to the schedule in Appendix 1 attached hereto and incorporated herein.

4. Invoice Instructions:

A. Invoices shall be submitted as follows:

- i. Each invoice must contain a purchase order number (to be provided by Company with a copy of the fully-signed Agreement) and must be dated upon receipt of purchase order number or thereafter. Invoices submitted to an incorrect address or without a purchase order number will not be paid.
