Science Editor: 1 Scientific quality: The manuscript describes a Case Report of the TEG-guided perioperative transfusion for FXI deficiency. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript presents a problem that is a very difficult deficiency to manage. The case report is well written and provides information that could be useful for management for this problem. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 2 figures; (4) References: A total of 15 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Written informed consent and CARE Checklist (2016). No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) PMID numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to
