mesenchymal Stem Cells (AD-MSCs), Stromal Vascular Fraction Cells (SVFs), in regenerative surgery. (3) Format: 2 tables and 1 figure. 33 references were cited, including 16 references published in the last three years. No self-citation. 2 Language evaluation: Grade B. Language editing certificate by filipodia was provided. 3 Academic norms and rules: The conflict-of-interest disclosure form and Copyright License Agreement were provided. Biostatistics Review Certificate was provided. No academic misconduct was found in the Bing search. The similar index is 37%, the repeated parts should be rephrased. 4 Supplementary comments: (1) Invited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in WJSC. 5 Issues raised: (1) Please write the "article highlights" section at the end of the main text; (2) The number of references is too small for a review. (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
