good, and the conclusions appropriately summarize the data that this study provided. However, there are some issues should be addressed. For some reference, the results and conclusions cited by the authors are puzzling. Some references are too old. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables. A total of 65 references are cited, including 26 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 6%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJG. The corresponding author has published 3 articles in the BPG. 5 Issues raised: The questions raised by the reviewers should be answered. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
