However, there are no references to the statement that CT AND ultrasound should be performed in all patients with portal hypertension and hernia, please add some related references. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 10 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by Textcheck was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and the written informed consent. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
